Cllr Barnett proposed the Parish Council recommend refusal to the application due to the size and massing of the proposal and the application has not addressed the Parish Councils previous concerns. The Parish Council request the ERYC maintain approval for the original application only. The new submission would impose a detrimental impact to neighbouring properties. The planting should use consistent evergreen to provide 12 months a year screening, prior to commencement of the development.
